The Connecticut Urban Forest Council will hold its Annual Urban Forest Council on February 29, 2024 at the Aqua Turf Club in Plantsville, CT. The Conference will run from 8:00 am until 3:15 pm.

The theme of this year's Conference is "**Demystifying Success in Urban Forestry**". It will highlight examples of successful urban forestry programs and projects within the state. Speakers will discuss the success of programs and projects with which they have been involved and tell what they learned from their experiences. In addition, during the meeting, the present and future direction being taken by urban forestry within the state will be discussed.
